Additional Conditions:

1. The unit shall operate the ETP efficiently and continuously so as to bring the quality of treated trade effluent meet the standards prescribed by the Board.
2. The unit shall utilize the treated effluent for gardening purposes within the premises of the unit.
3. The unit shall apply for authorization under Hazardous and other Wastes (Management and Transboundary Movement) Rules, 2016 for the disposal of ETP sludge to TSDF, Gummudipoondi within three months time.
4. The unit shall maintain hazardous waste display board in front of the main gate clearly updating the details of hazardous waste regularly as mandated by the Hon'ble Supreme Court Order dated 14.10.2003.
5. The unit activity shall not attract complaint from nearby area.
6. The unit shall continue to develop more green belt within the premises.
7. The unit shall not carryout manual cleaning of STP/ETP and shall carry out only through mechanical devices.
8. The unit shall submit Environmental Statement for every financial year ending the 31st March in Form -V as per the Rule 14 of the Environment (Protection) Rules, 1986.
9. The unit shall not use 'use and throwaway plastics' such as plastic sheets used for food wrapping, spreading on dining table etc., plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags irrespective of thickness, within the industry premises. Instead it shall encourage use of eco friendly alternative such as banana leaf, arecanut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, Jute bag etc.,
10. The unit shall comply with the E-waste management Rules, 2016. E-waste as listed in schedule -I generated by them shall be channelized through collection centre or dealer of authorised producer or the dismantler or through designated take back service provider of the producer to authorised dismantler or recycler. The unit shall maintain records of E-waste generated by them in form -2 and make such records available for scrutiny by the TNPCB. The unit shall file annual returns in form-3 to the TNPCB on or before the 30th day of June, following the financial year.
11. In case of revision of consent fee by the Government, the unit shall remit the difference in amount within one month from the date of notification. Failing to remit the consent fee, this consent order will be withdrawn without any notice and further action will be initiated against the unit as per law.
12. The unit shall remit the difference in Consent fee due to revision of the consent fee by the Board or due to increase in the GFA of the unit on demand.

Special Additional Conditions:

The unit shall install the approved retrofit emission control device/equipment with at least 70% Particulate matter reduction efficiency on all DG sets with capacity of 125 KVA and above or otherwise the unit shall be shift to gas based generators within the time frame prescribed in the notification No. TNPCB/Labs/DD(L)02151/2019 dated 10.06.2020 issued by TNPCB.

Additional Conditions:

1. The unit shall operate and maintain the air pollution control measures efficiently and continuously so as to bring the quality of emission to satisfy the AAQ/emission standards prescribed by the Board.
2. The unit shall adhere to the Ambient Noise Level standards prescribed by the Board.
3. The unit shall continue to develop adequate green belt with thick canopy within the premises, so as to attenuate air and noise pollution
4. In case of revision of consent fee by the Government, the unit shall remit the difference in amount within one month from the date of notification. Failing to remit the consent fee, this consent order will be withdrawn without any notice and further action will be initiated against the unit as per law.
5. The unit shall remit the difference in Consent fee due to revision of the consent fee by the Board or due to increase in the GFA of the unit on demand.
