### SPECIFIC CONDITION:

- The Applicant shall have to obtain Plastic Registration under Plastic Waste Management Rules, 2016.
- Unit shall obtain necessary CGWA permission in case of ground water withdrawal.
- Unit shall maintain zero liquid discharge.
- Unit shall have to submit approved action plan from urban develop department.

3. CONDITION UNDER THE WATER ACT

- 3.1 There shall be no generation of the industrial effluent from the manufacturing process and other ancillary industrial operations as the generated waste water shall be completely reused in cooling process.
- 3.2 The quantity of the domestic waste water shall not exceed 16.5 K L/day.
- 3.3 The Condition no 3(3.3) of CCA-32192 shall be amended and read as "Sewage shall be treated in the sewage treatment plant to confirm to the following standards and shall be utilized on land for gardening/plantation within the premises of industry & there shall be no discharge of Effluent outside the premises".
