Certified that **M/s I MATE ENGINEERING PVT. LTD., S.F.NO. 69, VEERAPPA GOUNDANUR ROAD, VADAPUDUR VILLAGE, KINATHUKADAVU TALUK, COIMBATORE – 641 109**, has been inspected and the building and premises are found satisfactory on the following aspects.

- The accommodation provided for each of the rooms and halls is sufficient for the minimum number of men stay.
- Ventilation, lighting that the building is maintained in substantial repair and Sanitary arrangements provided are adequate and satisfactory.
- The latrine arrangements are adequate and satisfactory.
- The supply of drinking water is wholesome and good.
- Premises and surrounding are maintained neat and clean.

**THIS CERTIFICATE IS USSED SUBJECT TO THE FOLLOWING CONDITIONS:**

- One any account the garbage shall not be burnt or kept more than 24 hours in the premises and should be collected and disposed by appointing required sanitary staff.
- Usages of plastics is prohibited.
- Fire pre cautionary measures and first aid box should be provided.
- Child Labour should not be engaged on any account.
- Overhead Tank and water sump shall be hermetically sealed and scientifically closed and shall not be breeding sources of mosquitoes.
- Drinking water shall be chlorinated and shall have 0.5 ppm of residual chlorine.
- To avoid overcrowding each should have 50 sq.ft of living space.
- Any outbreak of communicable disease must be informed to the Health authorities concerned immediately.
- All the food handlers should get the medical checkup for every 6 months and the fitness certificate must be submitted.
- The store rooms must be rodent free. and verified for expiry of Manufactures.

- There should be no Bed Bugs, rates and other insects control measures should taken once in 6 months in advised by the Health Authority.
- Fly/Mosquitoes breeding shall not be permitted within the premises.
- Display and exhibition of boards as per rule 3 of the Tamil Nadu prohibition and smoking and spitting rules 2003.
  - Every person in charge of public work or use shall display and exhibit a board at a conspicuous place in or outside the place prominently stating the place is as 'No smoking and No spitting place' and that 'Smoking or spitting here is an offence' which shall be both in Tamil and English and the version in English shall be in the second place below than Tamil.
  - The Tamil version shall be written predominantly n the board by providing more space than English.

This certificate is liable to be cancelled at any time on infringement if any of above said conditions and for improper maintenance of sanitation & building and, if any, health nuisance is found as defined in Tamil Nadu Public Health Act, 1939.
